CLYDESDALE AND CLYDESDALE WESTERN HOCKEY CLUB'S SAFEGUARDING POLICY (CHILDREN)

1. Purpose

This policy is to set forth Clydesdale and Clydesdale Western Hockey Club's statement of policy and procedures for the safeguarding of children. The policy lays out the commitments made by Clydesdale and Clydesdale Western Hockey Club, and informs staff, volunteers, and associated personnel of their responsibilities in relation to safeguarding.

2. Scope

- All staff contracted by Clydesdale and Clydesdale Western Hockey Club.
- Associated personnel whilst engaged with work or visits related to Clydesdale and Clydesdale Western Hockey Club including but not limited to the following: consultants, volunteers, members involved with children, contractors, programme visitors including journalists, professional players, celebrities, and politicians.

3. Policy Statement

Clydesdale and Clydesdale Western Hockey Club is fully committed to safeguarding the welfare of all children in its care. It recognises its responsibility to promote safe practice and to protect children from harm, abuse, and exploitation. Staff and volunteers must work together to embrace difference and diversity and to respect the rights of children and young people.

This policy outlines Clydesdale and Clydesdale Western Hockey Club's commitment to protecting children throughout its work, through the three pillars of prevention, reporting and response.

These guidelines are based on the following principles:

- the welfare of children is the primary concern.
- child protection is everyone's responsibility.
- all children – regardless of age, gender, being married or in a civil partnership, being pregnant or on maternity leave, disability, race including colour, nationality, ethnic or national origin, religion or belief, sex, or sexual orientation – have the right to protection from all forms of harm and abuse.

- children have the right to express views on all matters which affect them, should they wish to do so.
- organisations must work in partnership together with children and parents to promote the welfare, health, and development of children.

Clydesdale and Clydesdale Western Hockey Club will:

- promote the health and welfare of children by providing opportunities for them to take part in hockey safely.
- respect and promote the rights, wishes and feelings of children.
- promote and implement appropriate procedures to safeguard the wellbeing of children and to protect them from abuse.
- recruit, support and supervise its staff, members, and volunteers to adopt best practice to safeguard and protect children from abuse and to reduce risk to themselves.
- require staff, members, and volunteers to adopt and abide by this Safeguarding Policy and associated procedures.
- respond to any allegations of misconduct or abuse of children in line with this Policy and associated procedures as well as implementing, where appropriate, the relevant disciplinary and appeals procedures.
- regularly monitor and evaluate the implementation of this Policy and associated procedures.

4. Prevention

Clydesdale and Clydesdale Western Hockey Club's **responsibilities**.

Clydesdale and Clydesdale Western Hockey will:

- ensure all staff and volunteers have access to, are familiar with, and have acknowledged their responsibilities within this policy.
- design and undertake all its programmes and activities in a way that protects people from any risk of harm that may arise from their coming into contact with Clydesdale and Clydesdale Western Hockey Club. This includes the way in which information about individuals in our programmes is gathered and communicated.
- implement stringent safeguarding procedures when recruiting, managing, and deploying staff, volunteers, and associated personnel.
- ensure all staff, volunteers and associated personnel receive training on safeguarding at a level commensurate with their role in the club.
- will act on any reports of safeguarding concerns promptly and according to due process.

Staff and volunteer responsibilities.

Child safeguarding

Clydesdale and Clydesdale Western Hockey Club staff, volunteers and associated personnel must not:

- engage in sexual activity with anyone under the age of 18.
- sexually abuse or exploit children.
- subject a child to physical, emotional, or psychological abuse, or neglect.
- engage in any commercially exploitative activities with children.

Protection from sexual exploitation and abuse

Clydesdale and Clydesdale Western Hockey Club staff, volunteers and associated personnel must not:

- exchange money, employment, goods, or services, including team selection or the promise of team selection, for sexual activity.

Additionally, Clydesdale and Clydesdale Western Hockey Club staff, volunteers and associated personnel are obliged to:

- contribute to creating and maintaining an environment which prevents safeguarding violations and which promotes the implementation of this Safeguarding Policy.
- report any concerns or suspicions regarding safeguarding violations to the designated Safeguarding Officer, or to the appropriate staff member or to the appropriate authority in their absence in urgent cases.

5. Reporting a Concern

Clydesdale and Clydesdale Western Hockey Club will ensure that safe, appropriate, accessible means of reporting safeguarding concerns are made available to staff, volunteers, and the communities with which we work.

Clydesdale and Clydesdale Western Hockey Club will also accept complaints from external sources including members of the public, partners, and official bodies.

How to report a safeguarding concern

Staff members or volunteers who have a complaint or concern relating to safeguarding should report it immediately to the Safeguarding Officer or line manager [as appropriate]. If the staff member or volunteer does not feel comfortable reporting to their Safeguarding Officer or line manager (e.g. if they feel that the report will not be taken seriously, or if that person is implicated in the concern) they may report to any other appropriate staff/committee member and Scottish Hockey.

Response

Clydesdale and Clydesdale Western Hockey Club will follow up safeguarding reports and concerns according to this policy and procedure, and legal and statutory obligations.

Clydesdale and Clydesdale Western Hockey Club will apply appropriate disciplinary measures to any member of staff or volunteers found in breach of the policy.

Clydesdale and Clydesdale Western Hockey Club will offer support to survivors of harm caused by staff, volunteers, or associated personnel, regardless of whether a formal internal response is carried out (such as an internal investigation).

6. Confidentiality

It is essential that confidentiality is maintained at all stages of the process when dealing with safeguarding concerns. Information relating to the concern and subsequent case management should be shared on a need-to-know basis and must be kept secure at all times.

GDPR and child protection

GDPR emphasises the importance of asking children for consent before sharing personal information. If a child is mature enough, they should be given the opportunity to decide whether they agree to their confidential information being shared. If a child does not have the capacity to make their own decisions, their parent or carer (unless this would put the child at risk) should be consulted.

However, if there is a child protection concern, the information must be shared with the relevant agencies, even without consent. GDPR does not affect this principle.

7. Review

This Policy and associated Procedures will be regularly reviewed:

- in accordance with changes in legislation and guidance from Scottish Hockey on the protection of children or following any changes within Clydesdale and Clydesdale Western Hockey Club.
- following any issues or concerns raised about the protection of children within Clydesdale and Clydesdale Western Hockey Club.
- in all other circumstances, at least every three years.
